In line with DepEd Order No. 064, s. 2025, titled "Implementing Guidelines of the Academic Recovery and Accessible Learning (ARAL) Program," an orientation and training session will be held for volunteer tutors and ARAL Reading Program Teacher-Tutors. This activity supports the Republic Act (RA) No. 12028 (An Act Establishing an ARAL Program and Appropriating Funds Therefor), its implementing Rules and Regulations, DepEd Order (DO) No. 018, s. 2025 (Implementing Guidelines of the ARAL Program). It also reinforces the DepEd's commitment to engaging volunteer tutors and teacher-tutors as key partners in the school community on strengthening the delivery of focused and responsive academic recovery interventions.

This capability training aims to:

- Equip participants with a foundational understanding of the ARAL program's goals, methodologies, and expected outcomes.
- b. Develop participants' core tutoring skills, effective communication, and adaptive teaching strategies for diverse learners.
- c. Promote a collaborative spirit among teacher tutors in establishing clear communication channels and support mechanisms for ongoing program implementation.

To ensure the implementation of instructional time and prevent class disruptions, school heads must ensure that regular classes remain unaffected by the ARAL training. Where necessary, alternative modalities such as asynchronous or modular instruction may be used. Compliance with DepEd Order No. 9, s. 2005 and DepEd Order No. 012, s. 2025 is strictly required.

Moreover, service Credits shall be granted to all involved teachers while Compensatory Overtime Credits (COC) shall be given to the non-teaching personnel for the services rendered on Saturday and Sunday in the preparation for the said test (DepEd Order No. 53, s. 2003; CSC-DBM Joint Circular No. 2, s. 2015).

Meal expenses and accommodation for the core and division trainers involved in the conduct of this training shall be charged against the downloaded funds. Likewise, meal expenses for teacher-tutor participants, covering Day 1 snacks (morning and afternoon), lunch, and dinner, as well as Day 2 snacks (morning and afternoon) and lunch, shall also be charged against the downloaded funds.

Meanwhile, the traveling and incidental expenses of school participants, trainers, and TWGs in their respective districts shall be charged against the School/District MOOE, while those of division trainers and TWGs shall be charged against the Division MOOE, subject to the usual accounting and auditing rules and regulations.

Enclosed are the Schedule of Activities, the list of participants, which includes Program Management Team and Core and Division Trainers.
