In view of the challenges faced by our Schools in securing proper land ownership due to fragmented processes, overlapping claims, and a lack of coordinated actions among concerned agencies, Atty. Blake S. Feken and his team from RealtyPro & Diligence, Inc., together with the DepEd Central Office – Sites Titling Office (STO), have embarked on a pro-bono partnership to accelerate and streamline titling processes.

Ultimately, securing school land tenure ensures that present and future learners will continue to benefit from safe, stable, and legally protected learning environments.
