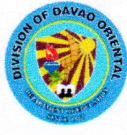

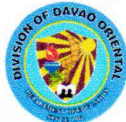

3. School Paper Advisers are directed to strictly comply with the online registration deadline on **December 6, 2025**, to allow the host district sufficient time to arrange accommodations for all participants.
4. The designated venues for the DSPC activities are **Manuel B. Guíñez National High School, Banaybanay Central Elementary School, and the Banaybanay Municipal Gymnasium.**
5. **The 2025 DSPC is a CPD-accredited activity. All eligible teaching and non-teaching personnel in attendance will be credited with 12 to 15 CPD units.**
6. Participants should note that the results for the morning individual events (Round 2 Qualifiers) on **December 12** will be released immediately before the afternoon activities resume.
7. School Paper Advisers and coaches are required to provide the specific name that must be printed on the Official Receipt (OR) for proper reimbursement and liquidation

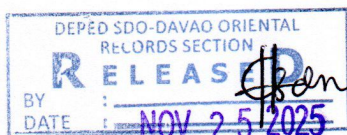

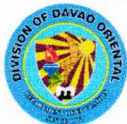
