Subject: **TURNOVER OF EDUKAHON BOXES TO EARTHQUAKE-AFFECTED COMMUNITIES IN DAVAO OCCIDENTAL AND GENERAL SANTOS CITY**

Date : June 23, 2026

1. Considering the recent impact of the magnitude 7.8 earthquake that struck Davao Occidental and General Santos City last June 8, 2026, the Schools Division of Davao Oriental will turn over *EduKahon* boxes to affected learners and teachers in both SDO Davao Occidental and SDO General Santos City on June 24–25, 2026.
2. These *EduKahon* boxes, which contain essential learning materials, are intended to support educational continuity despite the challenges brought by the disaster. These resources will help learners resume their studies and assist teachers in rebuilding classroom instruction while their respective communities recover from the devastation.
3. The official drop-off points for the distribution are designated as follows:
 - a. SDO Davao Occidental: Division Office, Brgy. Lacaron, Malita, Davao Occidental
 - b. SDO General Santos City: Division Office, Tiongson Street, Barangay Lagao, General Santos City
