**INVITATION TO BID**  
**PROCUREMENT FOR SUPPLY AND DISTRIBUTION OF CHEWABLE ASCORBIC ACID FOR**  
**GRADE VI SBFP BENEFICIARIES SY 2026-2027**

**Public Bidding No. GS-2026-122**

- 1) The **Schools Division of Davao Oriental** through the **FY 2026 Government Appropriations Act** <sup>1</sup> intends to apply the sum of **Three Million Nine Hundred Twenty-Four Thousand Seven Hundred Twenty Pesos Only (P3,924,720.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement for Supply and Distribution of Chewable Ascorbic Acid for Grade VI SBFP Beneficiaries SY 2026-2027**. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2) The **Schools Division of Davao Oriental** now invites bids for the above procurement project through open Competitive Bidding. Delivery of the Goods is required within the delivery period stated in Section VI. Schedule of Requirements of the Bidding Documents. Bidders should have completed at least ten (10) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from the **Schools Division of Davao Oriental** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM, Monday to Friday**.

Bidders intending to obtain the Bidding Documents on a Friday must notify the BAC Secretariat via email by Thursday, as the office operates under a work-from home arrangement on Fridays.

- 5) A complete set of Bidding Documents may be acquired by interested bidders from the BAC Secretariat starting **September 23, 2026, at 8:00 AM until October 12, 2026, at 11:45 AM**, upon submission of a duly accomplished Bidder's Information Sheet (Annex A) and payment of the applicable fee, in accordance with the latest guidelines issued by the GPPB.

For payments made via bank deposit, the proof of payment must be emailed immediately to the BAC Secretariat to facilitate the issuance of the Official Receipt. The non-refundable bidding fee may be paid either in person through the Division Cashier at the Schools Division Office of Davao Oriental or deposited to the following account:

The Bidding Documents may also be downloaded free of charge from **PhilGEPS** and the website of the Procuring Entity, provided that payment of the applicable fee shall be made not later than the submission of bids.

- 6) The Schools Division of Davao Oriental will hold a **Pre-Bid Conference on September 30, 2026, at 1:00 PM** to be held virtually. The conference shall be open to all prospective bidders through the following link:

- 7) Bids must be duly received by the BAC Secretariat at its office on or before **11:45 AM of October 12, 2026**.

**Late bids shall not be accepted.**

- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

- 9) **Bid opening** shall be conducted on **October 12, 2026, at 1:00 PM** at Madayaw Hall, Schools Division Office of Davao Oriental, Government Center, Dahican, City of Mati.

Bids will be opened in the presence of bidders' authorized representatives who choose to attend. Only one (1) representative per bidder shall be allowed to enter the venue.
